POSITION SUMMARY:

The role of Senior Jigsaw Clinician is suited to Social Workers, Psychotherapists, Occupational Therapists, Mental Health Nurses and Clinical/Counselling/Educational Psychologists with a minimum of 3 years' post qualification experience. The Senior Jigsaw Clinician works as part of the transdisciplinary Jigsaw team providing brief therapeutic supports to young people experiencing mild to moderate mental health difficulties. The Senior Jigsaw Clinician conducts assessments, delivers evidence informed brief interventions and participates in evaluation of the Jigsaw service. This role comes with a significant degree of responsibility as the Senior regularly deputises for the Clinical Manager, overseeing clinical decision making. The Senior plays a lead role in specific projects and service development, as required. They also have an opportunity to get involved in other activities to support youth mental health, e.g. mental health promotion, youth participation, online content development etc.

WHO WE ARE:

We are Jigsaw, the National Centre for Youth Mental Health. Formerly known as Headstrong, we were set up in 2006 and to this day, we remain committed to leading a nationwide transformation in the area of youth mental health. By joining the Jigsaw Team, you will help us to create an Ireland where every young person's mental health is valued and supported.

OUR VISION

We are a community of professionals, supporters, and volunteers with a shared belief in an Ireland where every young person's mental health is valued and supported.

OUR MISSION

We advance the mental health of young people in Ireland by influencing change, strengthening communities and delivering services through our evidence informed early intervention approach. Our network of Jigsaw services provide young people aged 12-25 with a place, or a digital space, they can visit for free and receive confidential support from trained mental health professionals.

In Jigsaw, one of our aims is to better inform, support, educate and empower communities, enabling a better understanding of our collective responsibility in supporting young people's mental health. Our youth mental health promotion work seeks to enhance community engagement and increase knowledge and understanding in relation to youth mental health. Our community-based workshops and programmes build the capacity of those who work or volunteer with young people, better equipping them to promote and support the mental health of young people where they live, learn, work and play.

Youth voice is central to our work in Jigsaw. We believe that youth participation is about involving young people, listening to them and giving them a voice in how our services and supports are planned, designed, implemented and evaluated. It means involving them in decisions in an appropriate, mutually respectful and meaningful way across all levels of the organisation.

We are changing the way Ireland thinks about and responds to young people's mental health. It is essential for our young people's mental health and wellbeing that we respond at the right time, in the right way. We work with Government, the HSE, policymakers and other stakeholders to make sure the right frameworks are being put in place to support Ireland's young people for generations to come.

PRIMARY RESPONSIBILITIES:

- To undertake initial mental health screening/assessments with young people focusing on both strengths and difficulties.
- To collaborate with young people in designing and implementing evidence informed brief therapeutic interventions.
- To undertake risk assessments and implement risk management plans as appropriate.
- To deputise for the Clinical Manager, as needed.
- To play a lead role in specific projects and service development as required.
- To liaise and consult with other professionals in supporting the mental health of young people attending Jigsaw.
- To work in accordance with Jigsaw Policies, Procedures and Guidelines.
- To participate in clinical supervision and line management for the purposes of support, guidance, direction and oversight.
- To participate in case management meetings, team meetings and other meetings as deemed necessary.
- To fulfil obligations as per the Children First Act 2015 and comply with the Jigsaw Child Protection and Welfare policy.
- To maintain accurate, confidential records of practice using the Jigsaw Data System and to cooperate with reporting requirements as per the Jigsaw Record Keeping Policy.
- To comply with responsibilities under the Data Protection Acts 1988, 2003 & 2018 (GDPR).
- To maintain professional and personal boundaries.
- To contribute to research, audit and evaluation of the service as required.
- To collaborate with the Youth Advisory Panel, as needed.
- To engage in other activities as required, e.g. mental health promotion, online content development, outreach work etc.
- To demonstrate an open and flexible attitude to work at all times.

- To be flexible regarding working hours in line with the needs of the service (incorporating late evening and weekend work).
- Additional responsibilities, reflective of the senior nature of this post, may be agreed by Management.

KNOWLEDGE, SKILLS AND EXPERIENCE REQUIRED

Essential Criteria: Qualifications & Accreditation/Registration – It is essential that you meet one of the below:

- Psychotherapist accredited by the Irish Council for Psychotherapy or the Irish Association for Counselling & Psychotherapy. (Psychotherapists must provide a copy of their current accreditation certificate/proof of accreditation at application stage).
- Social Worker registered with CORU.
- Occupational Therapist registered with CORU.
- Mental Health Nurse registered with An Bord Altranais.
- Doctorate or equivalent in Clinical/Counselling/Educational Psychology. (Psychologists who gained their qualification/s outside of the Republic of Ireland must provide a copy of their Letter of Validation from the Department of Health at application stage).

Experience

- A minimum of three years' full time or equivalent post qualification experience working in health, social care or related settings to support people with their mental health needs. (For psychologists, 3 years of this experience may have been spent in gaining the postgraduate professional qualification).
- Experience of core clinical mental health competencies; assessment, formulation, risk assessment and management, intervention and evaluation of outcome.

Desirable Criteria:

- Experience of working in a community mental health settings, ideally with young people.
- Experience of / training in evidence informed mental health interventions, e.g. brief solution focused therapy, cognitive behaviour therapy, acceptance and commitment therapy etc.
- Familiarity with Children First: National Guidance for the Protection and Welfare of Children (2017).
- Passion for working with young people within the Jigsaw Model.
- Full, clean driving licence and access to a car.

Skills

- Strong interpersonal skills and an ability to engage young people in assessment and therapeutic work.
- Ability to reflect on practice in order to facilitate personal learning, professional development and service improvement.
- Ability to manage casework on an independent basis.
- Ability to work co-operatively as part of a team.
- Strong time management skills and capacity to prioritise competing demands

- Effective communication and presentation skills including the ability to present information in a clear and concise manner.
- Ability to consult, liaise and negotiate with young people, carers, family members and other
 professionals in community mental health settings and with other community services for young
 people.
- Proficient level of computer literacy and competent in MS office, Office 365, Microsoft Teams,
 Zoom, SharePoint.

Salary commensurate with qualifications and experience. Factors taken into account in determining an appropriate scale include the candidate's knowledge, skills, experience and qualifications relevant to the job. The salary range for this role will be €46,000 - €62,000.
